#### **COMMITTEE REPORTS**

#### **Cable Action Committee**

Abraham reported there had not been a meeting this month as there were no items to consider.

The next CAC meeting will be a Zoom meeting, July 1 at 4:00 PM. Attorney Gojcai commented that it was expected that the legislature would not extend the mandatory zoom meetings. Franklin had had its first in-person meeting a few days ago. A hybrid approach would be possible through the Open Meetings Act using the 6 feet distancing rule and due to the scheduling and the availability of the Board Members McLain was in favor of having the CAC meeting the 2<sup>nd</sup> week in July. Gojcai encouraged an in-person meeting.

#### **PEG Committee**

Mydloski reported the committee met on May 19 immediately following the BACB meeting. Joining her in attendance at the PEG meeting were McLain, White, Fenberg, Tootell, Cleary, Abraham and Rota. The Beverly Hills Music in the Park on Friday, June 4 was discussed as to how it met the PEG stipulations and how it was compliant with the policies and procedures. Tootell had positive comments about the filming of the concert which had excellent attendance and mentioned there would be another one in July. Paperwork requesting another filming will be sent to the Beverly Hills Clerk.

There will not be a PEG meeting following this meeting.

#### **EXECUTIVE DIRECTOR'S REPORT**

White referred to her monthly report dated June 2021. There were two (2) new complaints since her last report. The first (1<sup>st</sup>) was a continuing complaint from a Birmingham resident who previously had a complaint about data overage fees and an installation fee from Comcast, all of which had been resolved. This new complaint involved service issues. Some of his equipment was replaced and he was satisfied. This complaint is closed. The second (2<sup>nd</sup>) complaint was from a Beverly Hills resident who wanted a large coil of cable removed from a utility pole across the street from his house. Not knowing whose cable it was, White sent the complaint to all three (3) cable providers. WOW promptly removed it. This complaint is closed.

#### **FINANCIAL**

Financial information for MBS, BBCU and Beverly Hills accounts for the month of May 2021 was emailed to the Board Members.

White wrote one (1) check since the last meeting for the PEG Grant to the Franklin Historical Society for its internet costs. This grant is consistent with previous years.

#### **ADDITIONAL NOTES**

Comcast notified BACB that it would not be broadcasting the traditional Newsy TV channel.

On June 3 she attended a webinar, presented by the Connecting Michigan Taskforce, which is a group of 13 different state agencies which better coordinate broadband activities within the state. The focus is on the 1.24 million Michigan households that do not have a fixed terrestrial broadband connection due to the lack of access or device, or service affordability. The federal efforts to address this problem were explained, some of which had been discussed by the BACB: Emergency Broadband Benefit program which was launched on May 12, NTIA Broadband Infrastructure Program, and Local Fiscal Recovery Funds. There are three (3) programs within Michigan which address these issues: Connecting Michigan Communities Grant Program, Michigan Infrastructure Council's "Dig Once" Project Portal and Michigan High Speed Internet Office which was newly created in the Department of Labor and Economic Opportunity.

McLain suggested that some of this information be put on BACB's home page. She, personally, will share this information with the MI NATOA. She shared a personal interaction she had had with someone in the Michigan thumb area who described the exact lack of connectivity, including that in the basement of a hospital.

Following up on the comments from last month's meeting about better and increased communication flow among the communities, McLain noted that CAC would be working on a new system.

#### PROVIDER RELATED TOPICS

#### a. Comcast

There was no representative present and no new information received.

#### b. AT&T/Uverse/Direct TV

There was no representative present and no new information received.

#### c. WOW

There was no representative present and no new information received.

McLain emphasized that the summer is a good time for residents to review and understand their cable bill. She also mentioned some of the common complaints which happen in the summer months: problems in the right of ways and downed cable lines, among others. She also listed the several rules of the franchise agreement which the cable providers have and must adhere to with

the four (4) communities. If residents are unable to resolve some issues with the providers, please contact the Cable Board.

#### **BAPA/BAMA REPORT**

Rota referred to his memo to BACB dated June 10, 2021. He listed the completed **BAMA** regularly scheduled municipal meetings. Franklin was the first to hold an in-person meeting this past Monday. It was a Village Council meeting at the Franklin Community Church. The meetings covered included the BACB Meeting, Baldwin Public Library Board and Trustee meeting, the Village of Bingham Farms meeting, the Beverly Hills Council meeting, the Village of Franklin Council meeting and its Board of Appeals and Planning Commission meetings, the City of Birmingham's Parks and Rec Board Meeting, Advisory Parking Committee meeting, Zoning Board meeting, the Multi-Modal Board meeting, Historic Board and Design Review Board Meetings.

For the **BAPA** Programs, 13 programs by producers and organizations (which he identified) were taped via Zoom. The Birmingham Republican Women's Club Lecture was in-person on location. The Beverly Hills Concert in the Park was very successful with the tri-caster multicamera production. The next one will be Friday, July 16.

#### PRODUCER WORKSHOP

Since the studio is closed, for those interested in producing a program or whomever wants to volunteer behind the scenes, please call the office at 248-433-7790 to set up a future time and date.

#### STUDIO UPDATE

Producers will begin in-person shows on Monday, July 12, 2021. At the end of the month Rota will begin recruiting volunteers and giving tours of the facility. Workshops for producers and volunteers will begin mid-July or early August. In-person meetings for the township will begin July 5. The hybrid meetings will begin in July.

#### MEETINGS TO MEET IN PERSON IN JULY

He will begin scheduling time and working with all four communities, testing equipment and setting everything up for the in-person meetings which will hopefully begin in July. Eric Brunk will be training him and some part-time staff on the coverage of the "hybrid meetings". He was in Beverly Hills testing equipment for hybrid meetings and experienced some technical problems. He is now working with Advanced Lighting and Sound on a resolution.

Mydloski thanked Rota for going above and beyond with personally helping with the technical difficulties experienced with the Franklin Village Council meeting.

#### **OLD BUSINESS**

Rota thanked Brunk and his team for all their help throughout the pandemic.

McLain attended the Birmingham/Bloomfield Chamber of Commerce networking event on behalf of the Cable Board. The successful program was online and involved eight (8) different

Chambers from different municipalities and she was able to give them an in-depth introduction to BACB and its mission.

Abraham had a personal experience with an increase in his Comcast bill. After much discussion with a company representative, he was able to reduce it down to the original price. The increase was the result of a promotion having expired. This is a reminder to everyone to check their bill, making sure it is for the correct equipment and for the correct service. For those who do not receive a paper bill, check your bank statement or credit card bill.

McLain added how important and critical it is to be connected for health and safety reasons.

Dear Chairperson McLain,

The Franklin-Bingham Fire Department currently obtains Internet access through contractual agreements with Comcast for fire station internet access, and Verizon Wireless for scene-based EMS incident reporting access. These services were selected based upon coverage, speed, cost and the ability to receive static IP addresses, so that we can host our public website as well as communicate with our personnel, via a secure internal web connection.

While we do not rely on county based systems, due to cost, we remain reliant on internet connectivity, in that we may be able to communicate effectively during normal times as well as when involved or as a result of emergency situations, including:

- Access to the Oakland County and State of Michigan Emergency systems
- Access to the State of Michigan Health Alert Network System
- Access to the State of Michigan mandated EMS report systems (MI-EMSIS & Stryker)
- Access to internet based fire records and training reporting systems (Emergency Reporting and FireRescuel Academt)
- Access to the US Fire Administration records site to upload our fire reports
- Access to multiple US DHS response and intelligence networks
- Access to NOAA severe weather services

Our department, like many others, relies on access to the internet, we are also faced with many of the same increasing costs of doing business. As a result, it is becoming more and more difficult to cost effectively meet our current obligations. With this in mind, I am writing to you to request any available grant assistance to the department to cover our internet connectivity costs of \$104.95 per month for Comcast fire-station internet service and \$119.97 per month for Verizon Wireless internet access. For the fiscal year starting July 1<sup>st</sup>, this would total \$2,699.04. Your support, if approved, would help us out that much more in providing our services to the public, by allowing us to maintain a level of service commensurate with our obligations. Thank you for any and all consideration and assistance and please feel free to contact me at 248.626.9862 with any questions, comments, or other information needs you may have.

#### **CUSTOMER COMPLAINTS**

We have received eight (8) complaints since the date of my last report. Complaint No. 2021-15 was received from a Birmingham resident who submitted previous complaints about data overage fees, billing and service issues which were resolved. This complaint involves his business in Birmingham. Comcast Business recommended a backup system in case its service went down but there have been several problems experienced by the subscriber in getting this backup system. These include improper charges, adding an unnecessary additional wireless network, failure to get Voice Mail installed, activation of Call Waiting which he does not want, and difficulties in getting his second line cancelled as he requested. The escalation team has assisted in getting the billing and services corrected and a Comcast representative came to the store to make sure the proper equipment and installation was in place. This complaint is now closed.

Complaint No. 2021-16 was received from a Beverly Hills resident who was not happy with her service from WOW and wanted to switch to Comcast. She had a lot of difficulty getting through to the proper department at Comcast to set up an appointment for a representative to come to her home to discuss becoming a new customer. When she finally was able to schedule an appointment, no one showed up on the designated date. An escalation team representative spoke to this resident and was able to get her new account set up for installation. The installation has now been completed and this complaint is closed.

Complaint No. 2021-17 was received from a Franklin resident whose email had been hacked and he was unable to access any older emails or his address book. He has requested technical assistance to correct these email issues. This complaint is pending.

Complaint No. 2021-18 was submitted directly to our website by a Birmingham resident. She was seeking assistance in getting Comcast to raise its lines which were laying on her driveway after a storm. She called Comcast on a Saturday and was told a technician would be out on Monday. No one showed up and when she contacted Comcast about this, she was then told it would take 7 to 14 days to handle the problem. This was unacceptable because she had not been able to get her car out of the garage. When we sent this complaint to the Comcast escalation team, they sent a technician out that same day and the lines were raised. Because she had been a Comcast customer since 1989, they also credited her account for one month of service due to the difficulty she had experienced. This complaint was closed and the resident was extremely grateful for the actions of BACB and the Comcast escalation team in resolving her complaint so promptly. However, the next morning the lines came down again in the same location and Complaint No. 2021-19 was submitted as a new complaint to insure a permanent resolution. Comcast immediately sent another technician to raise the lines and the resident is confident that the problem is solved. This complaint is now closed.

Complaint No. 2021-20 was submitted directly to our website by a Franklin resident. She has been trying for a long time to get a tangled mess of AT&T and Comcast lines cleaned up. Currently she states that there are bare AT&T wires that are hanging low enough to touch. This complaint has been forwarded to both AT&T and Comcast since the problem consists of a twisted and loose combination of lines owned by both companies. This complaint is pending.

Complaint No. 2021-21 was received from the maintenance manager of Williamsburg Condominiums in Birmingham concerning a WOW cable that was hit by a garbage truck. It was hanging about six feet from the ground in their parking lot and constituted a traffic hazard. WOW has raised the line to the proper height and this complaint is closed.

Complaint No.2021-22 was received from a Birmingham resident who is seeking to get Comcast to fix some low-hanging lines that are resting on his fence. This complaint is pending.
