## **COMMITTEE REPORTS**

#### **Cable Action Committee**

Abraham reported that the CAC did not have a meeting in January 2021 as there was nothing to discuss. The next scheduled meeting via Zoom will be Thursday, February 4, 2021. McLain suggested the newest members attend this meeting so they can go over the New Member Manual. For those who can not attend, an individual meeting can be scheduled.

#### **PEG Committee**

Mydloski stated the committee did not have a PEG meeting last month; however, on January 6 she attended the Program Development Committee meeting for BCTV, which will be discussed later in this meeting. There will be a PEG meeting directly following this meeting. McLain explained that the PEG meeting is open to anyone on the Board. PEG stands for Public Educational and Governmental Television.

# **EXECUTIVE DIRECTOR'S REPORT**

White referred to her monthly report dated January 14, 2021. There was only one (1) complaint since her last report. It was from a Franklin resident who stated that AT&T had improperly installed a cable wire from a telephone pole along hers and her neighbor's property line. The cable was hanging about a foot off the ground. This complaint is pending.

# **FINANCIAL**

Financial information for MBS, BBCU and Beverly Hills accounts as of December 31, 2020 was sent to the Board Members last night.

White wrote five (5) checks since the last meeting: the four (4) largest checks were for the Administrative Grants.

## **ADDITIONAL NOTES**

BACB sometimes crosses over into telecommunication matters. In this case, she reported about the bombing in Nashville and the impact it had on the telecommunications infrastructure which created major regional issues, especially with AT&T. She detailed the telecommunications outages in Tennessee, Kentucky and Alabama. Because of this, a U.S. Representative from Nashville wanted Congress to examine and reduce telecommunication vulnerabilities.

White will be compiling and emailing a new Board Member roster this month to all Board Members.

Tootell commented that the Nashville incident brought up the importance of connectivity and having a contingency plan. Due to her data communications network services and equipment experience, she has some background in these connectivity issues. She offered to help BACB if there was an interest in pursuing this matter. McLain suggested this be brought up in the CAC meeting. Tootell also added that censorship of peoples' voices being silenced was increasing on the different platforms. She questioned if there would be more demand on public access to be able to have a way of communicating more openly? Might BACB want to have some discussions about this? McLain noted that Rota would have and can explain specific rules and regulations to which BACB must conform.

McLain directed some questions to White about this month's Financials concerning the PEG and Franchise fees. White reminded her that this was a monthly report and directed her attention to the third column which reflected the revenues received up to December 20, 2020. White continued by explaining the specific quarterly payment process the providers follow. She also explained the process of transferring money to the Credit Union if or when the Fund Balance of an account is above a certain amount.

White answered Mydloski's inquiry about the memberships BACB has: the National NATOA, Michigan NATOA and Birmingham Chamber of Commerce.

Currier answered some questions posed by Tootell regarding the interlocal agreement, funding and restrictions. Tootell also questioned if there was any alternative funding for BACB.

# PROVIDER RELATED TOPICS

McLain gave a brief explanation that in the past each provider would have a representative come to these meetings; however, that has changed. Kyle Mazurek from Comcast will still come for his quarterly visit which is much appreciated. For the new members, each provider has an escalation team or individual who will work on any complaints or concerns BACB received from a resident about service or connectivity. She explained the process, pointing out that typically complaints are resolved within 24 hours after received by BACB.

White said that Mazurek from Comcast has sent her some information and she will report on it next month.

There was no representative present and no new information received.

## **BAPA/BAMA REPORT**

Steve Rota wished everyone a Happy New Year and welcomed the new Board members. He is the Operation Manager at Bloomfield Community Television and expounded on his responsibilities and duties.

He referred to his January 14, 2021 report and listed all the completed **BAMA** regularly scheduled municipal meetings: the BACB meeting, Parks and Rec Board meeting, Zoning Board meeting, Advisory Parking Committee meeting, the Multi-Modal Board meeting, Bingham Farms Council meeting and the Baldwin Public Library meeting.

He thanked Eric Brunk and his team who have been covering some of the Birmingham meetings since this past March.

He thanked everyone for their patience and the producers for their flexibility doing their shows through Zoom.

# PROGRAM DEVELOPMENT COMMITTEE MEETING

Referring to the already mentioned Committee meeting (Mydloski, Rota, Black and Diane Burk, a Birmingham resident, were in attendance) which was held January 6, 2021, two (2) new shows via Zoom were proposed and approved. However, both producers chose to wait until the studio opened before they began production. Pre-production will begin as soon as possible.

A PEG meeting will follow this meeting.

Rota reported that usually 700-800 shows are produced a year. These would include the public programs, the organizational programs, the sporting programs and all the meetings. The numbers for 2020 were different due to the pandemic; however, hopefully, that will change. He also identified and explained the responsibilities of all the staff members, part time workers and volunteers.

In addition, Rota informed the new members and residents how to view the different programing including all meetings: on the BACB website, on the Video on Demand portion of the website for past shows from 2010 to the current 2021, on the individual community's website and any rebroadcasts on WOW, Comcast or AT&T. For those who cut the cord, the programs can be seen on any community website, as well as on a phone.

At the moment no tours are scheduled; however, when it is deemed safe to have people in the studio Rota will continue the tours for all new and old members.

#### **CUSTOMER COMPLAINTS**

We have received one (1) complaint since the date of my last report. Complaint No. 2021-2 was received from a Birmingham resident who stated that she has been receiving much lower internet speed from Comcast than what she has been paying for. Although internet issues are not part of our core mission, we agreed to assist her as a courtesy and submitted her complaint to the Comcast escalation team. She also requested an adjustment to her bill due to this ongoing issue. On January 31, 2021, a service call was scheduled during which time the Comcast technician diagnosed and corrected the issue by replacing a defective inside wiring cable and defective modem. Service levels are now within specifications. In addition, a credit of \$168.04 was applied to her account, as well as a credit of \$39.99 for the in-home visit. The credits will be reflected on the subscriber's next bill. This complaint is now closed.

# **FINANCIAL**

#### **ADDITIONAL NOTES:**

- 1. Comcast has notified us that it is opening a new Xfinity Store at 1991 S. Telegraph Rd, Bloomfield Hills, MI. Comcast customers will have the opportunity to explore, learn about and interact directly with the latest Xfinity products and services, including the X1 Entertainment Operating System. Customers can also pay their bills using express payment kiosks. The new facility will operate expanded hours, Monday through Saturday from 9 am until 7 pm and on Sunday from noon to 5 pm.
- 2. Comcast is expanding its efforts to bridge the digital divide in Michigan. After completing the launch of its first 20 WiFi-connected "Lift Zones" in Detroit in early January, the company announced that it will expand this program to establish more locations across Michigan before the end of this year. Lift Zones are designed to help low-income students who, for a variety of reasons, are unable to connect to distance learning at home. Comcast provides robust WiFi hotspots in community safe spaces designed to help students get online, participate in distance learning and do their homework. Many of these sites also serve adults and can connect them to online adult education, job searches, healthcare information and public assistance. Any nonprofit organization, government agency, public housing or other establishment that is interested in becoming a Comcast Lift Zone and is located within the company's Michigan serviceable area can send an email to <a href="mailto:CENHRT\_LiftZones@comcast.com">CENHRT\_LiftZones@comcast.com</a> for more information. Criteria for becoming a Lift Zone include: (a) On-site adult supervision to monitor activity during all hours of operation, (b) Enforcement of COVID-safety protocols, (c) Allocation of adequate space with chairs and computers conducive for learning and (d) I.T. support.
- 3. Comcast also provides low-cost Internet service for \$9.95/month (plus additional taxes and fees), the option to purchase a heavily subsidized computer and multiple options for free digital literacy training through its Internet Essentials program. Comcast is providing 60 days of free Internet Essentials service for qualifying low-income families that sign up before June 30, 2021. Additionally, the company increased speeds for all new and existing Internet Essentials customers at no additional cost.
