White questioned if someone would like to take on this task? She is of the opinion that it was advantageous to touch base with the communities about who the Cable Board serves and what actions it has taken.

COMMITTEE REPORTS

Cable Action Committee

Abraham stated there was a short discussion after the last meeting about putting the new members' manual and other information on the BACB website. Since then, White has done that. He also suggested that a list of grants BACB has given be included.

PEG Committee

Kamoo stated there had not been a PEG meeting last month; however, there had been a discussion at the last full Board meeting concerning the future needs of the Birmingham schools. The School Administration will be contacting the different school administrators about this and will be contacting White. White is hoping to have all the information about the middle schools for the January meeting.

There was no need for a meeting this month.

EXECUTIVE DIRECTOR'S REPORT

White reported there were three (3) complaints this month, all of which she listed in her report. Two of them have been resolved. One involved a Comcast technician speaking to the resident explaining that her concerns about the cable wires on a new pole should be directed to AT&T as they were AT&T wires. This complaint is closed. The second complaint also involved a down wire. Comcast sent a crew out and did not find a wire down. This complaint is now closed. The third complaint which is pending involves the moving of lines to a new pole. The wires involved three providers: WOW, AT&T and Comcast, and will be resolved over time.

FINANCIAL

White provided the financial account balances for the MBS, Michigan United Credit Union and Beverly Hills as of October 31, 2022. This information was emailed to the Board members and hard copies will be distributed to Board members at the meeting.

CHECK DISBURSEMENT

She wrote eleven (11) checks, the largest of which was to the Charter Township of Bloomfield for the BACB quarterly contract payment. Some checks were for the grants which had been approved.

In it she requested the providers initiate the awarding of appropriate credits to those subscribers who have lost service. A copy of her letter is attached to her report. As of yet she has not had any responses.

Kyle Mazurek, Comcast's longtime Escalation Team representative to BACB has left the company. Eric Woody, Manager of Government and Regulatory Affairs, is his replacement. White included his contact information with the new Roster of Cable Board Members which she provided.

PROVIDER RELATED TOPICS

a. Comcast

There was no representative present. However, Gugni pointed out that in the six (6) years or more that he personally has been involved with the BACB, Kyle Mazurek had been the only

representative of any of the providers to come to a BACB meeting. He hopes that Eric Woody would come to the BACB meetings. Maybe a representative from AT&T and WOW would also attend.

b. AT&T/Uverse/Direct TV

There was no representative present.

c. WOW

There was no representative present.

BAPA/BAMA REPORT

Rota referred to his September 22, 2022 through November 16, 2022 memo to BACB, dated November 16, 2022. In his written report he listed all the regularly scheduled BAMA municipal meetings plus a Village of Franklin Special Headlee meeting and a Franklin Special Millage Video with the Village Administrator, Roger Fraser, Birmingham Study Session and two (2) City of Birmingham Workshops.

For the BAPA Programs, 26 individual producers and organizations programs were taped on location and in studio shows plus BACB Sports Water Polo, Swim and Dive and a Football game. Also covered were the League of Women Voters Village of Franklin Candidates Forum for Council, League of Women Voters Village of Bingham Farms Candidates Forum for Council and the Cultural Council of Birmingham Bloomfield 27th Annual Cultural Arts Awards, Daughters of American Revolution (DAR) Veterans Day Ceremony and the studio shows. Previously the shows had been on Zoom and now they are coming back to the studio.

PRODUCER AND VOLUNTEER WORKSHOP

Coming up will be six (6) to eight (8) BACB Sporting events: Boys Basketball, Girls Basketball, Wrestling, Boys Hockey, Girls Hockey and Boys Swim and Dive.

ADVANCED LIGHTING & SOUND

Gugni added the following item to this meeting's agenda.

Rota requested that Advanced Lighting & Sound be paid \$1,850.00 for the annual charge for "Cloud-based reflection service operating for both Cablecast Live and VOD servers" and an "ongoing subscription fee to maintain ONE branded Cablecast OTT channel" (formerly Screenweave). (BCTV will be billed \$1,050.00.) Rota explained this is the second (2nd) year and would be an annual recurring service.

Rota's request for \$408.75 for shirts from KTM Logo Gear, LLC will be postponed until the January meeting.

Motion by David, seconded by Eick to authorize the purchase of an annual Cloud-based reflection service and an ongoing subscription fee to maintain ONE branded Cablecast OTT channel in the amount not to exceed \$1,850.00.

Rota further explained that the bill is split 2/3 BACB for 2 channels (\$1,850.00) and 1/3 BCTV for 1 channel (\$1,050.00).

CUSTOMER COMPLAINTS

We have received four (4) complaints since the date of my last report. Complaint No. 2022-26 was filed on behalf of a Birmingham resident who lives next to a City-owned lot with many trees on it. One tree in the lot had been knocked over and was laying on the cable lines. The resident was concerned that it was eventually going to pull the lines down. Comcast has completed a site visit and it was determined with the homeowner that the tree was not an immediate hazard or risk to cable service. The escalation team has indicated that the homeowner was satisfied with the team's assessment and this complaint is now closed.

Complaint No. 2022-27 was submitted by a Beverly Hills resident (and Board Member) who had a Comcast line replaced after having service issues. After having difficulty getting the new line buried, he sought assistance from the escalation team. The line has since been buried but it still needed to be connected to the pole and the house. This matter has been resolved and this complaint is closed.

Complaint No. 2022-28 was submitted by a Beverly Hills resident who stated that he could not get the live Beverly Hills Council meetings. It appeared that he was getting the Bloomfield Hills and Bloomfield Township PEG channels rather than the BACB PEG channel. Comcast has indicated that the Beverly Hills community does not have an RDZ (regionally designated zone) in the video network today and does not have a direct fiber source into any of their Headend from a community studio. The escalation team member stated that the community nodes for Beverly Hills currently reside on the Bloomfield Hills PEG zone and that she suspected that they have a shared source agreement between the two communities for content to broadcast. She summed up the matter by stating that they do not have their own channel or designated path on the

Comcast video infrastructure. I am currently reviewing this response with BCTV and this complaint is pending.

Complaint no. 2023-1 was received from a Birmingham resident who had been having trouble with his Comcast email so he decided to change his email address. However, he was concerned that he may have forgotten to let some people know about the change and he wanted Comcast to set it up so that anyone who emailed him at the old address would get a message such as "undeliverable." This would be beneficial because those individuals would presumably then contact him by phone to get the new email address and would avoid a bunch of unanswered emails that were never received. The escalation team quickly resolved this matter and this complaint is now closed.

ADDITIONAL NOTES

1. We received a response from Comcast regarding the letter we sent to the providers requesting that they take the initiative in awarding appropriate credits to subscribers in the event of major outages. Eric Woody, Manager of Government and Regulatory Affairs has advised as follows:

Large-scale outages are extremely rare due to the redundancy designed into our network and diligence towards quality and security performed by our engineers and technicians. My manager could not recall the last time such a widespread outage has occurred in our area. I have provided a few scenarios to help answer your question.

- In the event of a declared natural disaster (examples would be a hurricane or mass flood) we have processes in place to compensate customer accounts for their service being down for an extreme length of time while recovery/restoration efforts are underway. This depends on the nature of the disaster, and we are fortunate that we live in an area not prone to widespread natural disasters.
- For non-disaster related events or incidents, we do assess proactive credits based on the affected areas and type of impact.
- For general service interruptions (such as a video channel event) and/or selected outage, customers may be eligible for credit as a result of this event. We offer a simplified and automated outage credit request process that the customer can use to quickly receive a credit for an outage or service interruption. The customer would sign into Xfinity.com on a mobile device or computer with their Xfinity ID and click on the check eligibility link to see if they qualify for an automatic credit for their outage. Customers may also utilize the Xfinity App to chat with customer service representatives. We have a support page article that details the process on our website or they can call 1-800-Xfinity.
- To help customers access outage information on demand, customers can check the status real time with our updated
 Outage Status Map to search for any potential outages that may be affecting them or their area real time. We offer customers the ability to opt in for outage text message alerts that will notify them if they are impacted by an event.
