The B&H quote of \$2,518 is for three (3) announcer headphones and three (3) broadcast headsets. The total amount of both would not exceed \$10,000.

APPROVAL OF BUDGET AMENDMENTS FOR FISCAL YEAR 2024-25

Cathy White, BACB Executive Director, provided a list of those accounts that need to be increased based upon this year's actual Expenditures: bank service charges be increased to \$90.00; HR services be increased to \$1,400.00; the milage budget be increased to \$950.00; Municipal support services increased to \$35,000 (this category will be changed to Municipal grants); and auditing be increased to \$15,500.

APPROVAL OF PROPOSED BACB BUDGET FOR FISCAL YEAR 2025-26

White presented the Current Budget-Year ended June 30, 2025 and the Proposed Budget-Year ending June 30, 2026. The Total Franchise Fee is lower to reflect the loss of subscribers.

Board Expenses are reduced due to not spending a lot of money in certain categories – Advertising and Conferences. HR Services have increased due to the costs which have increased this year. In the Auditing category there has been a significant increase. Municipal Grants have increased slightly.

PEG Revenue has decreased slightly. **Other Income** – MBS has increased.

PEG Operations and Expenses in that category – White has spoken with BCTV about their anticipated equipment needs for next year.

David commented that **PEG Revenue** is barely sufficient to pay the contractor costs for BCTV. He commented on this at the last meeting.

EXECUTIVE DIRECTOR'S REPORT - dated May 14

According to White it was a quiet month. Currently there are no pending complaints, and no new complaints have been received.

The Administration has proposed eliminating federal funding in its annual budget request and has issued an Executive Order to block support for PBS and NPR, cancelled grants that support the creation of children's educational programs and plans.

BAPA/BAMA Report

Regarding the BAMA Programs, Rota reported that all regularly scheduled municipal meetings, plus the City of Birmingham Workshops and two (2) Village of Franklin Workshops were completed.

There were 33 taped BAPA Programs from individual producers and organizations. The list is included in his report. In April there were two (2) BACB Sports Events: Girls Soccer games. Water Polo and Baseball will be tomorrow which ends the Spring games. The upcoming Spring coverage will be: Celebrate Birmingham Parade (May 18), Baseball (May 21), Birmingham Memorial Day Service in Shain Park (May 26), The Village of Beverly Hills Parade and Carnival (May 26). Concerts in the Park in Shain Park begin Wednesday, June 18-August 27.

Sports Production Camp begins August 11-14 (M-Th), August 18-20 (M-W). Times for (Aug. 11-18) will be 9 am-3 pm; (August 19) will be 2 pm -10 pm; and (August 20) 11 am to 2 pm. He included details of what would be covered, including the big production day (August 19) of soccer (Seaholm vs. Brother Rice) when, with the help of staff, the students can put together a sports program. On August 20th the students will be able to watch and celebrate what they had done. More information can be found at www.bloomfieldtwp.org.or call 248-433-7790. Applications are due June 5, 2025 and space is limited.

CUSTOMER COMPLAINTS

We have received two (2) complaints since the date of our last meeting. Complaint No. 2025-01 was received from a Beverly Hills resident who is planning to have DTE lines buried underground and is seeking assistance in getting the cable lines buried as well. This issue has been forwarded to all three providers' escalation representatives to address, and this complaint is pending. The Comcast representative has spoken to the resident and was informed that he does not currently have a plan for the DTE lines; therefore, Comcast cannot do anything until he has a plan. They did indicate that the homeowner would be responsible for the cost of relocating the lines underground.

Complaint No. 2025- 02 was received from a Beverly Hills resident who has been having issues with frequent disruptions of her Comcast cable and internet service. This complaint was forwarded to the Comcast escalation team representative who has reached out to her to discuss her complaint. Her service is currently working and she will receive a credit on her next billing statement. This complaint is now closed.

FINANCIAL

The account balance for the MBS, Michigan United Credit Union and Beverly Hills accounts as of June 30,2025 will be e-mailed to all Board members, as well as BACB financial reports as of June 30, 2025. Hard copies of these documents will also be distributed to Board Members at the meeting.

ADDITIONAL NOTES

- Requests for Proposals for performing the BACB annual audit were sent to several
 auditing firms to obtain competitive pricing for this service. The proposals will be
 reviewed in the Cable Action Committee immediately following the July 16, 2025,
 BACB regular meeting. Copies of these proposals will be emailed to all Board
 Members prior to the meeting.
- 2. An on-line article from Tech Crunch dated June 17, 2025, reported that streaming viewership in the United States exceeded cable and broadcast combined for the first time in May, 2025. According to Nielsen, streaming services accounted for 44.8% of all television viewership, their largest share to date. Total viewership for cable and network television accounted for 44.2% of all television viewership. When compared to May 2021, streaming usage has increased 71%, while broadcast is down 21% and cable is down 39%. YouTube had the highest viewership with 12.5% and Netflix followed with 7.5% of total viewership for the month.
 - Nielsen also noted that free streaming services have been a major driver of streaming's overall success: PlutoTV, Roku Channel and Tubi accounted for a combined 5.7% of total TV viewing in May.
